# **DOE'S ANGLING CLUB CONSTITUTION**

- 1.1** The Club shall be called "Doe's Angling Club" and its aims shall be to encourage the sport of angling in the district.
- 1.2** The affairs of the Club shall be controlled by an Executive of the Secretary, Chairperson, Treasurer, and a Committee of the following members:- Vice Chairperson, Fishery Management Officer, Match Secretary, Membership Secretary, Head Bailiff, Senior Members Liaison, Website Manager. These officers shall be elected by the membership as per rota at the Annual General Meeting and shall be over the age of 18 years. Voting powers shall be invested in each member. The Chairperson will consult on any matter requiring his vote with the Secretary and the Treasurer and then give his decision. The elected Committee have the authority to subsequently co-opt members on to the Committee during the annual terms as/if required to ensure the above Committee numbers are maintained.
- 1.3** Annual General Meeting of the Club must be held on or before the 16th June. At the Annual General Meeting the President and the Vice President are appointed and outgoing Officials may be re-elected if they wish. The Committee shall re-elect at this meeting and any Officer can seek re-election as per rota. For the purpose of a Quorum at any Annual or Special General Meeting there must be not fewer than 20 members present of adult status. Intermediate and Juniors attending such a meeting shall not be permitted to vote. Failing a Quorum the outgoing Officials shall remain in office until the conditions for such a meeting can be satisfied. Should a contingency arise whereby a meeting is void, another must be called within 28 days of the original date of the relevant meeting.
- 1.4** Meetings of the Committee shall be held at a suitable location during the second week of each month. Committee members are required to attend a minimum of eight meetings each year unless prior agreement has been obtained from the chairperson. Committee members failing to do so will be removed from their post and will not be eligible for re-election for one year from the following

AGM after removal from their position. At these meetings any member of the Club by prior arrangement with the chairperson may attend to discuss any item or matters concerning the Club under Agenda Item – Any Other Business –see rule 1.5. Discussion (other than rule 1.5) All voting at the Committee meeting is restricted to members of the Committee only. Should there arise any matter of importance requiring Committee attention only, all non Committee members will be required to leave the meeting and may return when the matter under discussion has been settled. Committee members are also responsible to inform the committee of any intended absences at all times.

- 1.5** Under the Agenda Item – Any Other Business non Committee members may be permitted to raise any matter provided it does not refer to discussed matters at the meeting. See rule 1.4 re attendance at committee meeting.
- 1.6** Reports of the previous Committee meeting must be given fully at the next meeting by the Secretary
- 1.7** If there should be less than 2 members present at a Committee meeting (excluding the Chairperson and the Secretary) the meeting shall be declared void.
- 1.8** The annual subscriptions to the Club shall be those operative as at the A.G.M. prior to the season opening and shall provide for the following classes of membership.
- 1.9** Adults. Concessionary (OAP Male 65 years/Female 65 years). Juniors (12 to 15 years inclusive no joining fee) and who reach their 16th birthday during the season at any time, whilst still in possession of a Junior membership, must be accompanied by an Adult Club member at all times. Membership upgrade is available on request to Intermediate membership 16 to 21 years . Two new passport sized photographs will be required to enable a new Club ID card to be issued. All persons, including Juniors and those who are non Club members must be accompanied by an Adult Club member. Disabled person's may be asked to provide proof of disablement. Match only non members are subject to the following:- No right to fish Club waters other than specified matches, No right to practice fishing after the specific matches other than a Guest Ticket fee being required, Guest Ticket persons with an Adult Club member must arrive and depart at the same time as their partner – must fish the adjacent swim to their partner if available or the next nearest swim.

- 2.0** The subscription shall cover the period 1st May through to the 30th April and be subject to annual review. For all age purposes the operative date shall be 1st May.
- 3.0** The finances of the Club shall be banked at the bank selected by the Treasurer and agreed by the Committee. The account to be in the name of the Club with the cheque books to be held by the Treasurer and Secretary. Cheques to be signed by 2 designated Committee members at all times. A copy of the specimen signatures of each nominated Committee member shall be held at the Club's bank.
- 4.0** The Secretary, Membership Secretary and the Match Secretary shall be provided with a receipt book and the monies received shall be accounted for directly to the Club Treasurer on a monthly basis. All financial matters must be cleared to the Treasurer not later than the 31st December annually. If banking directly to the Club account, certified receipt being received. All such receipts to be passed to the Treasurer on a monthly basis.
- 5.0** The allocation of Club funds shall be agreed by the Committee annually and shall be subject to periodic review.
- 6.0** The Match Secretary shall be responsible for all Club trophies, including the storage and distribution of same.
- 7.0** The Committee shall have the power to discipline, suspend or expel any member who shall be in breach of the Club's Constitution or the Club rules.
- 8.0** The member shall have the right to appeal to any disciplinary action, which must be made in writing only
- 9.0** The written appeal to be received by the Secretary within 14 days from the date of the Disciplinary letter.
- 10.0** The appeal to be reviewed at the next Committee meeting and the majority decision of the Committee shall be final and conclusive.
- 11.0** The Committee may invite as an honorary member any person who has given outstanding service to the Club. Honorary members shall not be required to pay an entrance fee or subscription.
- 12.0** Club Bailiffs to be under the control of the Head Bailiff, who will recommend to the Committee, suitable members for the approval as Bailiffs, by the Committee.



- 13.0** The Committee shall have the authority to repeal, amend and to add to the Club rules as they think expedient for the internal management and the well being of the Club.
- 14.0** All such rules repealed, or added by the Committee under rule 13.0 shall be binding on the members. The members to be advised of such a rule change by the newsletter and fishing notice boards, and also the club website.
- 15.0** Any proposal from members for the amendment to the Constitution, alteration of the rules, proposal of new rules, must be submitted in writing and be in the hands of the Secretary by the 18th December. The Club members to be advised of any such proposals, along with the date and venue of the Annual General Meeting.
- 16.0** Any such Constitution/rules changes with relevant amendments must be voted for, and passed by the majority of the members present voting at the Annual General Meeting or Special General Meeting.
- 17.0** Proposals from the floor of the meeting for amendments to the Constitution, alterations to the rules, or proposals of the new rules will not be accepted.
- 18.0** Any member shall have the power to call a Special General Meeting, by giving the Secretary not less than 28 days notice in writing, stating the reason for calling such a meeting and containing the signatures of at least 20 adult members.
- 19.0** Should the Special General Meeting cover resolutions for the amendment to the Constitution, alterations of the rules or proposals for the rule, items 16.0 and 17.0 shall apply to the proceedings.
- 20.0** Any member, irrespective of their length of membership, can join the Committee of Doe's Angling Club, if the Committee requires that person for their valued knowledge, to the benefit of the Club, they can then be co-opted to the Committee.
- 21.0** We now have a website [www.doesac.co.uk](http://www.doesac.co.uk) for current and new club information.
- 22.0** Dissolution a) If at any General Meeting of the Club, a resolution be passed calling for the dissolution of the Club, the Secretary shall immediately convene a Special General Meeting of the Club to be held not less than one month thereafter to discuss and vote on the resolution. b) If at that Special General Meeting, the resolution is carried by at least two-thirds of the full members present at the

meeting, the general Committee shall thereupon, or at such a date as shall have been specified in the resolution, proceed to realise the assets of the Club and discharge all debts and liabilities of the Club. c) After discharging all debts and liabilities of the Club, the remaining assets shall not be paid or distributed amongst the full members of the Club but shall be given or transferred to some other organisation having objects similar to those of the Club.

**23.0** All members or persons having reason for complaint against the Club or its members must present the complaint in writing within 14 days of complaint, addressed to the Club Secretary. All complaints requiring a reply must be accompanied by a stamped addressed envelope.

**24.0** The Committee of "Doe's Angling Club" hereby reserve the right to refuse membership without explanation.

**25.0** Under no circumstances will any/all members who by their own misconduct or disregard for any of the Club's rule or instructions and have either been suspended for an indefinite period of time or have had their membership from the Club withdrawn from the date of decision and the subsequent notice of such decision will not be entitled to any refund or part thereof or any membership fee that has been paid. All/any members who have been suspended or have had membership withdrawn must re-apply for membership in the appropriate manner.

**26.0 Health and Safety policy**

Does angling is committed to ensuring that we will do all that is reasonably practicable to prevent injury and damage to property. We will have due regard for protecting all other people who come into contact with the clubs activities. When dealing with health and safety issues, members and volunteers carrying out activities have a clear understanding of the need to operate within the context of this policy and arrangements. Officials, members and volunteers involved in events or work parties will take reasonable steps to safeguard all those taking part in activities and those who may be affected by them. Doe's Angling club will cooperate with other organisations and landowners to ensure risks are properly managed.

**27.0** Any committee member can be removed from the committee by a majority vote of the committee if they are not acting in the best interest of the club or are negligent in their duties.

## CLUB RULES

1. Current (Environment Agency) Rod Licence (except Juniors under 12) and the club membership card must be carried when on club waters and produced on request. Failure to produce these documents could/will result in you being required to leave the fishery.
2. All Environment Agency bylaws apply.
3. Fishery gates must be closed and locked after use.
4. Speed limit on any riparian owner's property is 10 mph.
5. Juniors under 16 must be accompanied by an adult club member at all times whilst on club waters.
6. All litter of any description, including unwanted bait, sandwiches etc must be taken away by the angler.
7. The use of radios, tapes and CD players is restricted to those capable of being listened to via personal ear pieces and even these are to be kept to a volume inaudible to adjacent anglers.  
Mobile Phones - Members who have the use of these phones whilst on club waters, please use for the minimum time so as not to interfere with other members fishing near you.
8. The following are not allowed on riparian owners land:- a) the lighting of fires, b) animal snares or traps of any kind, the presence or use of guns unless authorised by the committee. c) pets (with the exception of guide dogs, whose owners should make the committee aware). d) drones.
9. The following baits are banned:- bloodworm, joker, particle baits and all nut types excluding hemp,tares and sweetcorn
10. **No more than two rods are to be used at any one time.**
11. No Carp (excluding Crucians) to be put in keepnets except at matches. Minimum keepnet size is 10ft long- opening to be at least 16 inches x 14 inches. No more than 50lbs of fish to be put in a single keepnet.
12. All fixed lead rigs are banned together with elasticated feeders, with the exception of Guru X safe system of feeders.
13. No baited lines to be left unattended at any time.
14. All hooks must be barbless and maximum of size 8. The only exception is microbarbed hooks which can be used for silver fish in size 18 and smaller.
- 14a. Braid lines and braid hook links are banned. Maximum leger weight size is 1oz.

15. Fish over 5lbs (8lbs in matches) must be returned to the water immediately after weighing and not retained in a keepnet at any time. No fish to be retained in keepnets for longer than 5 hours (except club matches).
16. Beeleigh – the owner of the lower lake will not allow Juniors on the water at any time.
17. Night Fishing is allowed on Welham Mere Only and for a maximum of 48 hours. Members will require a Night Fishing Permit which must be applied for at the time of new membership. Guests are not allowed to night fish on club waters.
18. **All anglers must have unhooking mats and landing nets when fishing club waters.**
19. No radio controlled bait boats to be used on any of our Club waters.
20. The cost of replacement rule books will be £2.00 and the cost of replacement membership cards will be £5.00.
21. BIVVIES. The erection of Bivvies at the top and bottom of Twitty Fee No. 2 is not allowed. The erection of Bivvies at the two sides of Twitty Fee and Beeleigh Top Lake may only be erected as to not cause any inconvenience or nuisance to other Club members.
22. Waters/Venues where a work party has been allocated and are, or have been, in progress will be closed all day and will only be opened at the fishery manager's discretion. This is to adhere to the Club's health and safety insurance requirements. Only members who have assisted on any work party past or present will be allowed to fish these venues on these days, again at the fishery manager's discretion.
23. All Matches. Competitions which have not been approved by the Committee and which have an end result, whether a reward of any description or a Winner decided, and with more than 4 member's taking part, will be deemed as illegal. Any/all members found to have taken part in unauthorised Matches will be suspended by the Club for a period to be decided by the Committee. The Over 60's fixtures on Wednesday, Sunday fixtures plus Charity fixtures are the only authorised fixtures allowed by the Club. All other such matches where more than 4 members are taking part will not be allowed. Only one match will be allowed to be held on the same venue at the same time.
24. Guest Tickets. Anglers must carry a hard copy of guest tickets or have it available for view on their mobile phone. Any/all members

wishing to take up to 2 guests must have purchased the appropriate guest tickets before fishing and they are only applicable from sunrise to sunset. Also the guests must be in adjoining swims. All Committee members are in possession of guest tickets and these can also be purchased on the website [www.doesac.co.uk](http://www.doesac.co.uk) Tickets are not available to be purchased on the bank unless a prior arrangement has been made and permission given by a current Committee member. All members found to be in breach of this ruling will be reported to the Committee and could result in disciplinary action being taken.

25. No alcohol or drugs are allowed to be used or consumed on Does AC waters.
26. Any rod used must only have one hook attached to the line except when pike fishing.
27. Driving around Beeleigh Top Lake in or on any form of motor vehicle is forbidden.
28. If a swim is marked by barriers or tape this means the swim is not to be entered or fished.
29. Anglers must fish in marked swims only.
30. The maximum breaking strain of line to be used on our waters is 12lbs, unless in season pike fishing.
31. No tins or glass bottles are allowed on club waters.
32. When ledgering, bite indicators that are capable of registering drop-backs as well as runs must be used.
33. **Anyone found defecating at club lakes will be banned instantly.**

**Remarks** - Members who are fishing with poles on Club waters, please do not pull your elastic line by your hands when bringing in your fish as if the hook comes out, the power of your elastic when returning is very dangerous to you.

On venues where matches have been allocated or are taking place, the water will be closed on the date of the match from 6.00 am until 2 hours after the conclusion of the match. Such match venues will show a "Match taking place" board on the entry gate. Only persons taking part in the match may fish the water between these times. Venues not showing a match board will be open to all members and guest tickets.

## MATCH RULES

### These rules are in addition to the Club's General Rules

1. The draw will take place 90 minutes before start of the match.
2. The minimum number of competitors for a match is five.
3. A match may be cancelled if there are insufficient competitors, or if for any reason the water is unfishable. It can also be moved to an alternative venue. In this instance members already fishing the new venue will take precedence over match anglers.
4. The water may only be broken prior to the start of a match for the following:- a) plumbing the depth, b) obtaining water for mixing ground bait, c) placing keep nets, d) only one line and one hook to be used at any one time.
5. All matches on all club waters require competitors to be in possession of two keep nets, to be used in tandem, to accommodate the possible large number of fish being caught with one being used for silver fish only. Failure to comply will result in disqualification.
6. No competitor shall have more than one rod, line and hook in the water at any one time.
7. Any competitor "Playing" a fish on the final whistle should shout, "Playing" and a further 15 minutes will be allowed to land the fish.
8. A competitor's catch will not be weighed if litter is on the peg area. If litter is evident on the peg on arrival this fact should be brought to the attention of the match official before the peg is occupied.
9. It is the responsibility of each competitor to check and agree their weight. Once recorded the result will stand. Anglers must be present at the weigh in of their own catch. Failure to do so will result in disqualification from the match.
10. Adult match angler of the year will be the best 5 results out of 6 rounds that will count.
11. All keep nets to be dipped before use where tanks are provided.
12. All competitors to have and use unhooking mats at all times.
13. Braid lines and braid hook links are banned. Maximum leger weight 1oz
14. Pull bungs are now allowed on Does waters.

- 14a. On venues where matches have been allocated or are taking place, the water will be closed on the date of the match from 6.00 am until 2 hours after the conclusion of the match. Such match venues will show a "Match taking place" board on the entry gate. Only persons taking part in the match may fish the water between these times. Venues not showing a match board will be open to all members and guest tickets.
15. A maximum of 50lbs of fish per keepnet and any excess will not count towards your match weight. Persistent offenders will at the match secretaries discretion be exempted from the match results
16. Carp and silver fish (inc Crucians) are not to be placed in the same keepnets and any offenders found will at the match secretaries discretion, forfeit their entire match weight. Persistent offenders could also receive a 3 match ban.
17. You must attend at least 6 concessionary matches to be able to fish the concessionary Christmas match.  
Also you must attend 6 club Sunday matches to be able to fish the club Sunday Christmas match.
18. Members can hire the lakes for matches if given prior approval from the committee. The fee for hiring a lake for 1 day is £120 or £10 per peg which ever the greater.
19. All members attending matches will be required to pay an additional £1 fee to the club to pay for match equipment & trophy's. This money will be held by the match secretary who will provide a statement to the committee on a monthly basis. At the end of each season any outstanding monies will be handed to the club treasurer.
20. Mugging Fish in matches is allowed but anglers must be seated at all times.

### **Special Notice**

The match secretaries reserve the right to alter the venue or time of the match to suit the relevant conditions. Please check with the appropriate match secretary during the week prior to the match date.

### **NOTES**

Please check the website for match bookings and to contact Match Secretaries about availability as some matches have been over subscribed.

## **WELHAM MERE RULES**

- 1.** No Litter will be tolerated. You will be asked to leave if there is litter in or around your swim.
- 2.** Physical or verbal abuse of club officials will result in an immediate ban from the syndicate.
- 3.** All fish to be returned to the water as soon as possible no keepnet's or sacks.
- 4.** Maximum 2 rods only. No unattended rods.
- 5.** No Baitboat's.
- 6.** Fishing dawn to dusk only unless in the possession of a night ticket which is for the maximum of 48hr in one session.
- 7.** No barbed or bent hooks. Maximum hook size 8.
- 8.** Braided line and hooklink's are banned. Maximum breaking strain of line 15lbs.
- 9.** No alcohol, drugs or fires.
- 10.** No peanuts or tigernuts.
- 11.** Fixed leads and elasticated feeders are banned. Maximum lead weight 1.5 ounces.
- 12.** Pole fishing is banned at this water.
- 13.** No Under 18's and guest tickets allowed on this lake.
- 14.** All anglers must use the following equipment:-
  - a) Large Landing net – at least 36 inches.
  - b) Large padded unhooking mat.
  - c) A large weigh sling.
- 15.** All other club rules apply.



# **DOES AC – PIKE FISHING SEASON**

**October 1st 2024 to March 15th 2025 inclusive**

## **Rules and Regulations**

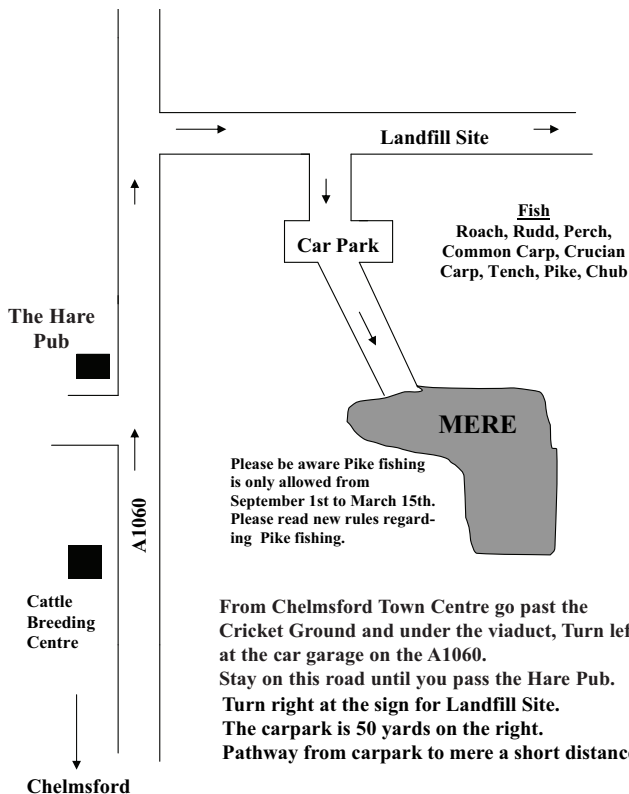
In order to protect the future of pike fishing on our waters, anglers specifically fishing for pike are asked to adhere to the below rules in relation to tackle, handling and care of fish.

1. Use a minimum of 12lb breaking strain line.
2. No braid line to be used in any way (See Club Rule 14a).
3. Wire traces should be untreated stainless steel.
4. Traces should be at least 18 inches and minimum 25lbs.
5. Hooks should be barbless or semi-barbless to a maximum size 8.
6. Artery forceps of a minimum of 9 inches must be used.
7. Carry a set of side cutters for removal of problem hooks.
8. Always carry and use a suitable unhooking mat (Club Rule 18).
9. Unhook fish using a gloved hand if possible for your own safety.
10. Pike gags are banned on club waters.
11. Landing nets should be of knotless mesh and have a minimum of 36inch arms
12. Indicators that are capable of showing “dropbacks” as well as runs must be used.
13. Always strike quickly and do not wait for the fish to “turn” the bait.
14. Photograph fish immediately and return to the water.
15. When returning fish to the water, please ensure that they have fully recovered before releasing them.
16. We do not allow pike fishing in the warmer months when dissolved oxygen levels are at their lowest as pike always give everything in the fight and it would endanger their chances of a full recovery.
17. Remember these fish are very delicate, despite their reputation to contrary. Please look after them to guarantee our sport for the future.
18. Live baiting is banned on all Does AC waters.

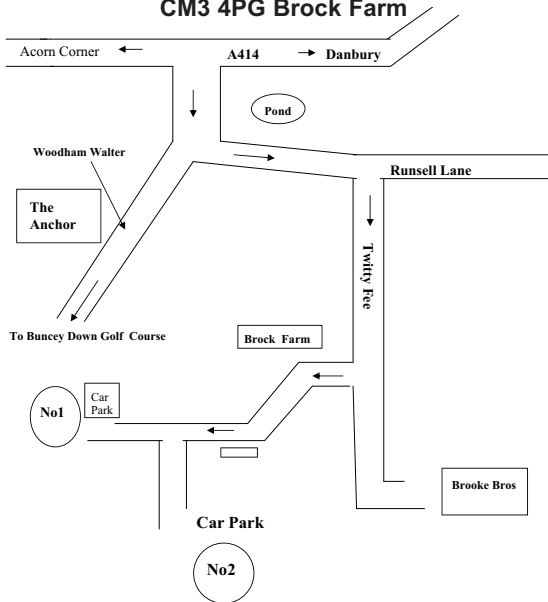

A very good mixed fishery with excellent results from our match members. Some nice Rudd, Tench, Roach, Crucian Carp and there are some larger carp up to 10lbs which give good sport on a pole

### Twitty Fee No2

Its mainly a Carp water and some match weights have been over 120lbs. It fishes well off the top at certain times but is a consistent fishery all season with most methods. We have no very large Carp but many low doubles.

Please make sure gates are shut upon arrival and departure including the entrance gate to Brock Farm as security is every club members responsibility.

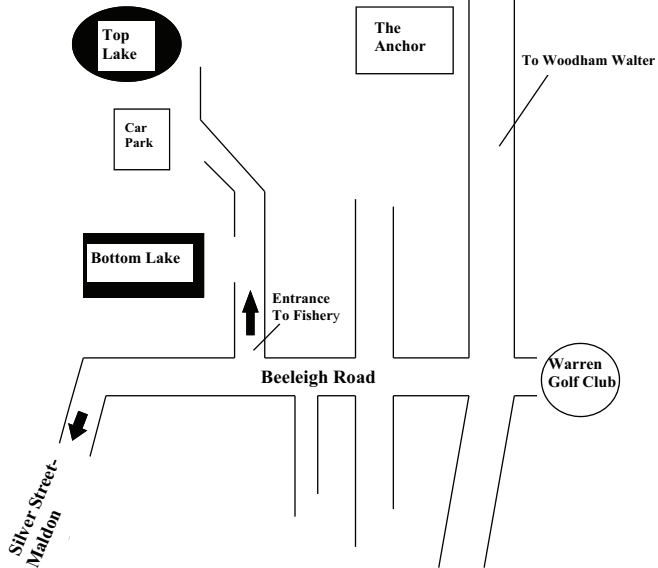

Beeleigh Top Lake is quite a shallow venue with depths to 6ft and is very open as the trees need more time to mature. Carp are the predominant species with some larger fish but excellent Roach and Tench have been caught. There are 36 swims available with good parking at both venues.

Beeleigh Lower Lake is a very productive water with Tench, Crucian Carp, Chub, Perch, Roach, Rudd and the usual Carp with some larger fish. This is a very sheltered venue for those windy days and has depths to 8ft. It has 32 swims available

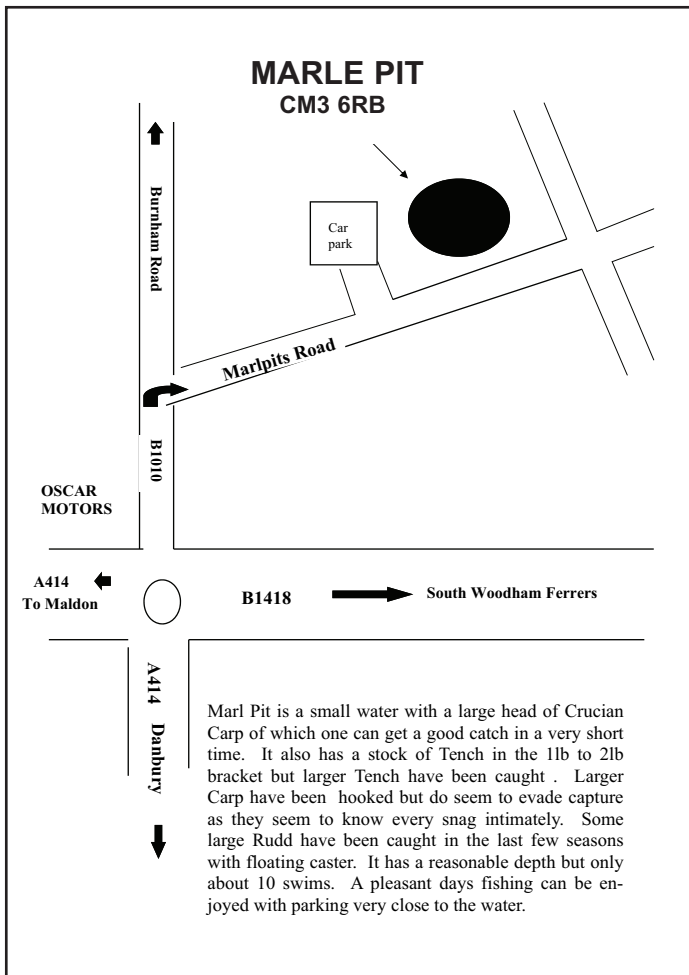
The lake was dug approximately 30 years ago and is one acre in size. 12 swims are available at present but a few more could be made at work parties. Fish present are some nice size Tench/Crucian Carp/ Rudd/Roach/and skimmer Bream. A few reasonable size Carp are also available to test your skill.

**Please park at the upper car park in wet conditions.**

Also please be aware the owner has a caravan site at the top and he sells day tickets to his guests and the money received is given to the club. Please keep your speed down whilst on the Fruit Farm as children and others wander about.

# MARLE PIT

CM3 6RB



Marl Pit is a small water with a large head of Crucian Carp of which one can get a good catch in a very short time. It also has a stock of Tench in the 1lb to 2lb bracket but larger Tench have been caught. Larger Carp have been hooked but do seem to evade capture as they seem to know every snag intimately. Some large Rudd have been caught in the last few seasons with floating caster. It has a reasonable depth but only about 10 swims. A pleasant days fishing can be enjoyed with parking very close to the water.
